## **105 W 3rd Street** Architectural Style: Other Vernacular The Doege Building

Built in 1901-02 on Lot 4 of Block 80, 108 W. 3rd Street, this was the first office built by Dr. Karl W. Doege, one of the founders of the Marshfield Clinic, and Dr. Walter Sexton. It was moved to its current location when the Purdy School was built in 1919/1920 & then served as the city's Chamber of Commerce & public restrooms. The rectilinear brick building has a hip roof with 3 dormer windows, & a turret with octagonal roof at one corner. The continuous horizontal bands reflect the 3 stories. The recessed entrance has the original entry with transom above; all entry windows now infilled. Windows on the west & north sides are slightly arched, some half infilled with brick, & have protruding sills; there is one infilled window on the wall just beyond the turret. The decorative banding below the roofline is brightly painted for its current usage.

### DR. K. W. DOEGE DIES; HEART ATTACK FATAL TO EMINENT SURGEON

#### **PRACTICED HERE OVER 40 YEARS**

### Deceased Headed Marshfield Clinic and St. Joseph Hospital Staff

### FINAL RITES THURSDAY

Dr. K. W. Doege, president of The Marshfield Clinic, chief-of-staff at St. Joseph's hospital and former president of The Wisconsin Surgical society, succumbed to a heart attack at his home, 309 Park Avenue, shortly before 9 o'clock this morning. He was 65 years old.

Dr. Doege had suffered from ill health since June 10, a few weeks following his return from an extended stay in Europe where he studied the treatment of cancer, and since that time was confined to his bed. His condition rapidly grew worse during the past few days.

Members of the family were present when he died. They said the doctor had not been fully conscious during the few days before his death.

The Rev. M. R. Laird will officiate at funeral services in the Doege home at 2 o'clock Thursday afternoon. The remains will be entombed in the family mausoleum in Hillside cemetery.

Out of respect to his memory, the Marshfield Clinic will be closed all day Thursday.

### In City Over 40 Years

State-wide renown as a surgeon came to Dr. Doege through the success that attended the practice he established in Marshfield more than 40 years ago.

Out of this practice and a partnership with other local surgeons and physicians the Marshfield Clinic grew, attaining a position of unusual prominence in the medical world, a mecca alike for the ailing and for knowledge seeking surgeons and medical students, attracted from all points of the state by the skill of Dr. Doege and his colleagues.

In the public mind Dr. Doege has long been regarded as a most skillful and versatile surgeon, operating, with equal facility on every part of the body. His operating room experience was constantly being supplemented with extensive research experiments and investigations at leading medical centers in the United States and in Europe. He is credited with having performed most delicate and astounding operations.

One of the members of the American College of Surgeons, Dr. Doege also was a member of The American Medical association, The Wisconsin Medical society, The Wisconsin Surgical society and The Ninth Councillor Medical society. As a member of the German Surgical society he made 13 trips to Berlin during his career to attend and lecture at meetings of that organization. He also attended meetings of the German Society of Internal Medicine, the most recent of which was held at Wiesbaden during his last sojourn in Europe.

#### **Born In Germany**

Dr. Doege, born in Germany April 22, 1867, received his education in the common schools of his native land and came to the United States with his parents when he was 14 years old. At Milwaukee he devoted four years to study in a seminary for teachers. While teaching the German language in a public school at St. Paul he revealed a predilection for medicine and surgery. He received his M. D. degree at the Western Reserve School of Medicine in Cleveland in 1890 and immediately began the practice of his profession in Marshfield.

Dr. Doege gave immutable attention to his profession and throughout his career the amount of work he accomplished was fabulous. During his earlier years he performed many operations at his then comparatively modern establishment on West Third street. His office building occupied part of the present site of the Purdy school and later was moved across the street where it now is being used as a public rest room and headquarters for the Marshfield Commercial Club.

Through Dr. Doege's eminence as a surgeon and physician Marshfield and central Wisconsin residents have for years found open for them an avenue of relief, away from the large population centers. He won wide acclaim even in his earlier years and his surgical skill brought frequent demands for his services from doctors in other cities.

## **Formed Clinic**

In 1917 Dr. Doege, with six other surgeons and physicians, organized the Marshfield Clinic, an association of which he has always been president. One of his greatest ambitions was realized in the construction of the new clinic building with its elaborate and complete equipment for di-

agnosing and treating human ailments. Through his constant efforts in this direction definite progress has also marked the development of St Joseph's hospital in this city. Much of the equipment and special facilities found in this institution for the care of medical and surgical patients was installed under his direction.

So constant was the demand for his services, and so eager was he to advance his knowledge of medical and surgical science, that little time remained for Dr. Doege to devote attention or energy to civic affairs, although he never declined to be of whatever assistance he could in that respect.

He possessed a high appreciation for music and when Marshfield several years ago became affiliated with the Civic Music association he became president of the local concert unit.

**Street Bears His Name** As a mark of respect and tribute to his leadership the common council selected his name for one of the city's streets.

Dr. Doege in 1891 married Miss Frieda Walz, of Cleveland, Ohio. They had two sons. Dr. Karl H. Doege and Dr. Paul Doege, both members of the Marshfield Clinic, who have been closely associated with their father in the practice of their profession. Mrs. Doege died in 1927. Two years ago, on November 4, Dr. Doege married Miss Elizabeth Myerhoff, the ceremony taking place in Hildesheim, Germany. She survives him. Dr. Doege s only brother, Herman Doege, of Thorp, died in St. Joseph's hospital here several days ago.

## MARSHFIELD CLINIC IS MEDICAL CENTER

Dr. K. W. Doege Established Institution 21 Years Ago in City

A monument to the life work of the late Dr. K. W. Doege is the Marshfield Clinic, established under his supervision in 1916.

The present clinic is a corporation of 14 physicians and surgeons affiliated for group practice of medicine, each member a specialist in his own particular field.

Throughout the 20 years of its existence the clinic has carried out the ideals of Dr. Doege, who believed that the doctors, by intimate association in their work, constant study, and mutual assistance would gradually develop along well defined lines to a high standard of efficiency in their particular fields.

The original group included Dr. Doege, Dr. H. H. Milbee, Dr. V. A. Mason, Dr. R. P. Potter, Dr. William Hipke, and Dr. W. G. Sexton.

As the clinic grew, rented quarters became outmoded, and in 1926 the Clinic building on S. Central avenue was erected. No expense is spared to provide the latest and best in equipment and apparatus for the treatment of patients.

"Throughout central Wisconsin, the clinic has become known for its work in medical and surgical circles, and the quality of its staff, most of the members of which have had a portion of their training abroad.






## The Restroom.



1884 (Nov.) Sanborn Insurance Map, Marshfield, WI, Block 80




1887 (Oct.) Sanborn Insurance Map, Marshfield, WI, Block 80




1891 (Nov.) Sanborn Insurance Map, Marshfield, WI, Block 80

# **First medical building still stands**

here is an interesting building located at 105 W. Third St. It is interesting for several reasons. First, it has moved. Second, it is a very early medical facility, belonging to one of the founders of Marshfield Clinic. Third, it still basically is the same as when it was built.

The building was built in 1900 at the location of the present Angelus Retirement Community, better known as the Purdy Building or Purdy Junior High. It was built for Dr. Karl Doege as his office and lab. It was the first building built for medical purposes in Marshfield, and from it Dr. Doege made house calls in his horse and buggy.

The examining rooms were on the first floor and the lab was upstairs in what today is a bedroom. The original oak floor is still there. When the area was converted into the bedroom, the floor was studded with many black spots — acid burns from the chemicals used in the medical tests by Dr. Doege.


When it was decided to build the Purdy school at its present location, the office was moved across the street to its present location.

After the five doctors joined together to create what was to become the Marshfield Clinic, the building was left vacant. The Marshfield Chamber of Commerce was located there in 1921, as was a public restroom, according to the city directory for that year.

In 1940, Dr. Martin Dornfeld, a brother of

the Rev. Dornfeld of Marshfield, opened a chiropratic office in the building.

When Dr. Dornfeld died in a boating accident on Half Moon Lake in October 1943, a friend of Dr. Irvin Dracht contacted him in Milwaukee and told him of the opening. He moved to Marshfield and opened his office here in 1944, buying the building.

Dr. Dracht was born in Medford in 1914 and had graduated from Medford High School and Lincoln Chiropractic College in Indiana. He was a musician and played with local dance bands before attending college. He played guitar, violin, clarinet and his favorite instrument, the trombone.

After moving to Marshfield and establishing his office, he met his future wife, Marietta Draxler of Auburndale. They were married Oct. 7, 1944. They first lived in the apartment above the office that had been created by Dr. Dornfeld. This creation had been the only modification to the original exterior of the building. He had extended the front of the second floor slightly to add space to the living room.

The Drachts lived in the apartment until the birth of the second of their nine children. At that time they moved into a home on Adler Road.

The Dracht family continued to own the building until 2010, a total of 66 years. It was sold to the Stoney River Assisted Living LLC company, which occupies it today.

Dr. Irvin Dracht died in 2001. Sons Dr. Irwin Dracht II and Dr. Paul Dracht of Marshfield carry on the family tradition.
